



## **RULES AND REGULATIONS**

Please read the following carefully before signing and returning your Entry Form

### **THE EVENT**

1. The Italian Job is organised & promoted in aid of Children Charities. It is understood that each team shall use their best endeavours to reach their target of £1500.00 or to raise as much money as possible. Raising money for the nominated Charities is a condition of Entry.
2. Support of other Charitable Projects is strictly subject to the Organisers approval.
3. All sponsorship money collected must be sent ASAP to the Organisers Office. Any money donated to entrants to defray their costs is a matter between the two parties so long as the donor is in full agreement.
4. Unless otherwise stated all Sponsorship money raised will be divided as follows:  
85% to the nominated Charities – 15% to the Italian Job development Fund  
Subject to prior arrangements with the Organisers, Overseas Participants will be permitted to donate up to 50% of the sponsorship money raised to a registered Children's Charity within their own country.
5. The event name and logo cannot be reproduced without the explicit prior consent of the Organisers.
6. The Charity's name and logo cannot be reproduced without the explicit prior consent of the Charity.
7. Acceptance of an application for participation will be sent within 14 days of receipt of a completed and signed Entry Form which must be accompanied by the full entry fee or a deposit of minimum £ 250.00.
8. The organisers reserve the right to decline acceptance of an application for participation.

### **DRIVERS AND VEHICLES**

9. Minimum age requirement for all Drivers is 21 years - 19 for co. drivers. Younger persons may participate only if accompanied by a parent or legal guardian & may be excluded from participating in the sports event. The event is NOT recommended for young Children.
10. All vehicles must be Mini, Mini based Kit Cars or Classic Cars featured in the original film.
11. Both doors of each participating vehicle are reserved for displaying Official Decals and Team Number and must be kept Free of advertising and sponsors messages.
12. All Drivers and co-drivers must fully comply with the European Highway Code and on request be able to present Valid Driving licences – Log Book – Car Insurance certificate- MOT certificate with at least 6 months validity – Green Card – Continental breakdown Cover as well as all legally required spares parts.
13. All vehicle must pass the Official Scrutineering and document check prior to being admitted to the sport event. Failure to comply with or part of clause 11 and 12 will result in the non participation in the sport event and in such cases no compensation or refunds will be given to defaulting Teams.
14. Irresponsible driving and/or behaviour may result in immediate expulsion from the event.
15. To qualify for the Finisher Awards or Certificate of Participation Teams must check-in at the Registration Point, all Pit Stops en route and at the Finish Line on the date, time and place specified each year in the final itinerary which is distributed by the end of September.

## **PAYMENT AND CANCELLATION**

16. The Entry Fee includes: Return Ferry crossing for car and passengers, all visits & refreshments detailed in the final itinerary, Official decals & numbers, Jobbers baseball cap, Souvenir Programme, Finishers Award, Certificate of participation, Fundraising Help Pack, Full time assistance of the Organisers Office, Assistance of a Service Crew and Organisers Team escorting the event, Team participation in the Sport event including local permits, liability insurance during the Navigational Rally, Road Book, Scrutineering, Briefings, Classification & Awards, service charges & local taxes.
17. The Team Entry Fee of £ 500,- can be paid in full at the time of Registration OR 50% as initial deposit and additional 50% by June 30th .  
Hotel and social programme costs will be advised by April and Full Payment is due by August 1st .
19. All cheques must be made payable to The Italian Job and sent to the organisers office.
18. Cancellation Must be made in writing together with full account of all sponsorship received. The following charges will apply: up to 30th March = £ 50.00 - From 1st April to 30th June = £ 100.00 From 01st July to 31st August £ 250.00. Cancellation on or after September 1st will be treated as a non show unless replaced by an alternative team.
19. The organisers reserve the right to apply a Late payment admin fee of £ 20.00 per person.
20. All quoted costs are based upon currency exchange rates valid at the month of March. The organisers reserve the right to apply a reasonable increase in case of an unfavourable currency fluctuation against the Sterling.

## **LIABILITY**

21. The Organisers cannot accept responsibility for any vehicle or personal loss howsoever incurred.  
Full comprehensive Car Insurance and European breakdown Cover is a condition of Entry (see rule 12. )  
Personal and medical Insurance cover is also highly recommended.
23. The Organisers cannot accept responsibility for any additional costs incurred by participants as a result of weather, closure of ports, industrial action etc. If any such events occur the Organisers will endeavour to act in the best interests of all participants.
24. The organisers reserve the right to amend the itinerary location or services, as they shall in their absolute discretion deem necessary.
25. It is understood that the signature on the Entry Form signifies understanding, acceptance and compliance with all above Rules & Regulations, by ALL persons named on the Entry Form.
